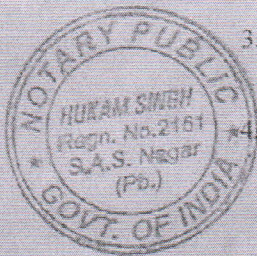

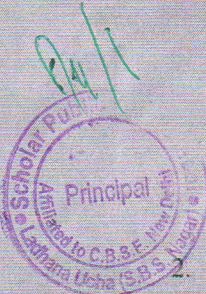
With reference to subject cited above.

2. After thoroughly considering the documents alongwith Affidavits submitted by the School Management, recommendations of the District Education Officer (S.E.) and Director Public Instruction (S.E.), Punjab, Chandigarh, necessary no objection certificate is granted by the Punjab Government on the under mentioned conditions :-

1. In Future on any complaint/ Inspection if it comes to notice that while seeking no objection certificate from the Government, Application submitted on the basis of wrong information and or inspections by the Punjab Government are not complied with by you and the conditions and such conditions mentioned in affidavit are not accepted, then in such circumstances at any time the said no objection certificate can be withdrawn.
2. It will be compulsory to give education of Punjabi in your School and the C.B.S.E. New Delhi shall surely make arrangements to take exam of Punjabi of such Schools inter alia it is also stated that in the event of not doing so the no objection certificate shall be immediately withdrawn.
3. Notifications issue under R.T.E. Act, 2009 by the School Management, Education Department, Punjab Government and rules framed under the R.T.E. Act 2009 for Punjab State shall be complied with mutatis mutandi After getting affiliation with C.B.S.E. New Delhi the School Management is bound to pay the salary and other allowances as per Government Employees to the teaching staff and non-teaching staff of the school vide account payee cheques, in the event of not doing so the no objection certificate shall be withdraw immediately.
5. You and Your Management will also ensure that as soon as any information is sought by the District Education Officer of your district or any officer of the Education Department, the same shall be made available vis a vis to provide necessary co-operation
